#### General Goals

After having taken this class students should be able to:

1) Analyze and discuss the forces that are leading to new relationships between the transnational migration and its regulation by national governments and other international bodies.

2) Use theoretical tools to reflect upon specific empirical cases.

3) Reflect upon what forms of policies might be most reasonable in addressing the problems discussed in the course.

4) Reflect upon their own experiences as transnational migrants in the context of the discussions, lectures, and readings.

#### Teaching

The class will be based on a series of lectures, as well as student-led seminars in which readings and lectures are discussed. The course organizer will function as moderators in the seminars. Since the participants in the class come from diverse backgrounds the students' own experiences form an important component in these discussions.

Students are supposed to meet outside the course. The meetings provide an opportunity for students to explore and discuss the topic of their interest, share experiences and to network.

#### **Course Requirements**

- 1. Take part in ALL lectures and seminars
- 2. Do all the weekly readings, and be active participants in the seminars.
- 3. You may co-lead one or more class discussions during the course
- 4. A project
- 5. A final paper (ca 2000 words)

Students are expected to conduct and present a specific project that addresses the topic of migration of their choice. The final paper will be a critical reflection on the process of their work by analysing and referring to the course literature and their ethnographic practice.

Since you have two final assignments to deliver, one practice-based project/intervention and one final paper, you need to start thinking of what is your specific topic, site or situation with which you want to work from the first day. Throughout the course we will back and forth discuss your chosen topic, site or situation of migration in order to frame and narrow down your specific project into a feasible and doable work within the short time of this course.

All students will be assessed for their active participation in class, their oral presentations of the project and for the quality of their final paper.
